Amended, the Clerk will prepare the call as indicated.


Tuesdays: All cases filed prior to March 27, 2020.

Beginning February 1, 2021, until further order of the Court the following schedule shall be in place for court cases.

Traffic:

- All matters scheduled to be heard in either Courtroom 201 and Courtroom 210 shall be heard collectively in Courtroom 201. Court call times are 9:00am, 10:30am and 1:30pm.
- All matters scheduled in Courtroom 209 shall be heard collectively in Courtroom 209 at 9:00am, 10:30am and 1:30pm.

Misdemeanors:

- All matters scheduled to be heard in Courtroom 102 and Courtroom 105 shall be heard collectively in Courtroom 105. Court call times are 9:00am, 10:30am and 1:30pm.
- All matters scheduled to be heard in Courtroom 207 and Courtroom 208 shall be heard collectively in Courtroom 207. Court call times are 9:00am, 10:30am and 1:30pm.

Statutory Summary Suspension Hearings:

- All Statutory Summary Suspension Hearings will be heard as follows:
 - Cases originating in Courtrooms 102 and 105 will be heard in Courtroom 105 collectively.
 - Cases originating in Courtrooms 207 and 208 will be heard in Courtroom 207 collectively.
 - Times for Statutory Summary Suspension Hearings will be at 2:30pm and 3:30pm for all rooms.
 - Once a petition for Statutory Summary Suspension Hearing is filed a hearing date shall be confirmed with the appropriate courtroom (105 or 207) and time (2:30pm or 3:30pm).
 - All witnesses will be allowed to testify by Zoom.


