**EXPEDITED BOND HEARING SCHEDULING ORDER
CRIMINAL DIVISION**

THE COURT FINDS THAT:

To ensure that the court operates to hear all emergency requests for bail review as expeditiously as possible; To limit the risk of jail detainees being exposed to the COVID-19 virus, yet balance the rights of the accused and public safety; To give the Cook County Sheriff the enhanced ability to exercise social distancing in the jail; To protect court personnel and attorneys from exposure to the virus; and, To assist in giving affect to the Governor’s “shelter in place” order; it has become necessary to hear the maximum number of requests in the shortest period of time.

IT IS HEREBY ORDERED:

1. The assigned judge for each courtroom (or the judge sitting in their stead) will appear in their regular courtroom to hear motions with respect to bond of detainees, assigned to that courtroom, pursuant to the schedule attached hereto.
2. This expedited bond hearing process shall only apply to the following class of defendants:
 - a. All detainees who are at an elevated risk of contracting COVID-19, either because of their age or because of underlying health conditions, such as diabetes, asthma or hypertension, among others;
 - b. All pregnant women;
 - c. All detainees who are being confined on misdemeanor charges, felony charges as to which they are probationable or non-violent felony charges, including in particular all non-violent class 3 and class 4 felony charges;

- d. All detainees who are being confined following a judicial determination that they are bailable, but who remain in Jail because they are unable to pay the money bond set in their cases;
- e. All detainees who are being confined following arrest on a warrant or upon an allegation of parole or probation violation and who are not charged with or suspected of a crime of violence;
- f. All prisoners serving sentences of imprisonment in the Jail;
- g. All detainees who are eligible for release only if they satisfy the conditions of electronic monitoring but who remain in the jail because they have "no place to stay."

3. This expedited process shall apply to those cases where the defendant's appearance is waived, except as set forth in paragraph six (6) below. If the defendant's appearance is not waived, counsel may still be heard using the emergency motion process previously put in place.

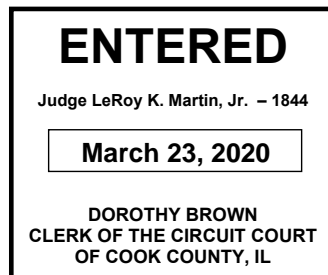
4. For this expedited bond hearing process, a written motion shall not be required, however, counsel should notify the State of their intention to appear.

5. Anyone who does not fall within the class of detainees covered by this order and any detainee otherwise wishing to be heard may avail themselves of the emergency motion process as previously set forth with notice to the State and to the Cook County Sheriff or the Illinois Department of Corrections.

6. The State shall identify pro se defendants and facilitate the issuance of a writ to the jail for them to be heard in open court. Unlike represented defendants, pro se defendants must be present for their hearings.
