**GENERAL ADMINISTRATIVE ORDER: 2021-02
SUBJECT: THIRD DISTRICT COURT OPERATIONS**

IT IS HEREBY ORDERED, except as otherwise mandated by the General Administrative Order, the Third District is hearing all matters in all divisions in person.

First appearance traffic cases, status dates, and any other matters, other than hearings or trials, can occur via Zoom and at the discretion of the judge presiding.

Courtrooms are only allowed 32-56 people at a time, depending on its size, per Cook County Bureau of Asset Management.

The Domestic Relations Courtrooms (105 & 106) are being handled off site and remotely and will follow guidelines established by Domestic Relations Presiding Judge Grace Dickler.

Each designated courtroom is listed below with the times previously set. All times subject to change depending on the numbers of cases on the calls.

ZOOM IDs and required passwords for each room are attached hereto.

Jury trials will be heard at this time until we can accommodate them with social distancing.
