GENERAL ADMINISTRATIVE ORDER NO. 2014-05

**SUBJECT: STATUS DATES AFTER SUBSTITUTION OF JUDGE OR RECUSAL
(SUPERCEDES GENERAL ADMINISTRATIVE ORDER NO. 2014-03)**


The following procedures for motions for substitution of judge as of right or recusal shall be in effect for all Chancery Division and Mortgage Foreclosure calendars:

IT IS HEREBY ORDERED:

1. This general administrative order replaces General Administrative Order 2014-03.
2. Any case that is reassigned pursuant to a substitution of judge order, disqualification of judge order, or recusal of judge order must be set for a status hearing by the newly assigned judge's law clerk. Within fourteen (14) days of the date of entry of the attached order, movant¹ must, and any other party may, contact the newly assigned judge's law clerk to obtain a status date before the newly assigned judge. The newly assigned judge will schedule the new status date through entry of a court order that will be distributed to all parties by the movant, or the party initially contacting the judge's law clerk after reassignment.
3. The requirement to contact the newly assigned judge's law clerk to obtain a status date does not apply to those mortgage foreclosure cases where the judge recuses himself or herself pursuant to a judge's specific standing order and pursuant to General Administrative Order 2014-04, and any amendments or replacements thereto.

¹ In the event a case is reassigned pursuant to a recusal by the judge, and a case management date is not automatically assigned upon reassignment, "movant" will be considered to mean the plaintiff.
