GENERAL ADMINISTRATIVE ORDER NO. 2014-02

SUBJECT: MOTIONS FOR SUBSTITUTION OF JUDGE AS OF RIGHT

The following procedures for motions for substitution of judge as of right shall be in effect for all Chancery Division and Mortgage Foreclosure calendars:

IT IS HEREBY ORDERED:

1. A Motion for Substitution of Judge as of Right may only be presented before the judge to whom the case is currently assigned and pending.
2. If the judge regularly assigned to the case is absent, then the Motion shall be continued and heard when the judge returns using the attached form order.
3. If a litigant or an attorney objects to the covering judge hearing any matter, the matter shall be continued for the regular judge to hear, except in cases of emergency¹, when it can be heard by the Supervising Judge or Presiding Judge of the Chancery Division.
4. In cases of emergency¹ and for good cause shown, the Motion for Substitution of Judge as of Right may be brought before the Presiding Judge of the Chancery Division.
