**ORDER**

This matter coming to be heard on the Court's own motion, and the court having been fully advised in the premises, the court hereby states:

On April 28, 2014, the Chancery Court for the State of Delaware, entered an order for Rehabilitation and Injunctive Relief, placing Freestone Insurance Company, formerly known as Dallas National Insurance Company, into receivership. The Illinois Guaranty Fund Act provides: "All proceedings arising out of a claim under a policy of insurance written by an insolvent company shall be stayed for 120 days from the date of the entry of the Order of Rehabilitation/Liquidation."

Therefore, it is anticipated that there will be many motions filed in the Law Division and First Municipal District, asking that cases involving parties insured by Freestone Insurance Company, f/k/a Dallas National Insurance Company, be stayed and/or transferred to the Insurance Calendar. It is in the interests of justice and judicial economy will be best served by the designation of one judge to hear these motions on a consolidated basis.

IT IS HEREBY ORDERED:

1. All pending and subsequently filed motion seeking a stay of proceedings and transfer of the case to the Insurance Calendar, involving parties insured by Freestone Insurance Company, f/k/a Dallas National Insurance Company, are consolidated;
2. This order applies to all such motions filed prior to the date of the consolidated hearing;
3. Judge Kathy M. Flanagan is designated to hear the consolidated motions on June 25, 2014 at 9:00 AM, Room 2210, Richard J. Daley Center.
